Sub: No objection for partial prepayment in connection to listed, rated, secured, redeemable non-convertible debentures issued by Edelweiss Asset Reconstruction Company Limited ('the Company'), bearing ISIN INE015L07709 ("Debentures" or "NCDs").

We are acting as Debenture Trustee for Debenture holders of listed, rated, secured, redeemable Non-Convertible Debentures ("NCDs") aggregating to Rs.1125 Crores (Indian Rupees One Thousand One Hundred and Twenty-Five Crores only) issued by Edelweiss Asset Reconstruction Company Limited ("the Company") under Debenture Trust Deed ("DTD") dated 27th November 2019.

Pursuant to the same the debenture holder has provided its consent for the said partial prepayment vide their letter dated 24th April 2023 and email dated 26th April 2023 (both copies enclosed).

In view of the said clause 2.4 (b) of Schedule I, the Issuer can proceed with voluntary redemption upon the approval of the Debenture Trustee who in turn shall act on the approved instructions of the Debenture Holder.

Based on the above facts and consents received, we provide our no -objection towards partial prepayment of NCDs along with interest & redemption premium as applicable subject to the Covenants and the security cover of the issuance being maintained.
